Superintendent's Report

- The Locating equipment has been purchased and received however I returned it after opening the shipping box and finding the equipment was used. Dirt prep has told me over the phone that as soon as they receive a new un-opened box they will ship.
- Contract for Superintendent as well as DRC. Orrin Lehr our DRC (direct responsible in-charge) Needs to be reimbursed for his mileage to and from Seaside Oregon for his training. It has been over a year! 454 miles @.070/ mile =\$317.80. Vote
- Monday 06/01/2026 I and a volunteer did an R+R on the water line at the Welcome Station. So now the property owner can water the flowers the volunteers planted. I am sending a bill via Rainbow Water District to the property owner for 1 yard hydrant and 1 double check valve 1 double threaded 90 1 double threaded nipple and 2 threaded PEX nipples and 2 PEX clamps not to mention other cost. This is intended to go directly to the Water District bank account. \$150.00 This is a very great deal for the property owner and the community!
